34/16 CHAIRMAN'S ANNOUNCEMENTS

To celebrate the Queen's 90th birthday the church is having on 12th June evensong followed by refreshments and Hilary Hall has asked if a marquee can be erected on the green in front of the church. – No objections. It is suggested that she might be able to apply for a grant.

Sweetcroft have asked if occupants of the converted barn could have pedestrian access through their back wall onto the Church Green. After a brief discussion no objections.

The sale of The Barn Church St has highlighted that the land in front of it is owned by the Parish. An agreement is to be drawn up to allow the new occupants limited access across the land. Any alterations to the property which may affect the access is to be monitored.

GG has contacted the Environment Agency re reclassifying the land between Townsend & the Childrey Brook. Despite the fact that the EA has verbally designated it as a zone 2 flood area in Jan. 2015, the written records have not been updated. EA promised it would be done in the autumn update.
