Mr. Vicars has been contacted re Parish land outside his property. He would like PC to take back the upkeep.

School expansion. OCC would like to take over some of the playing fields, KS & CS plus 3 members of EHPC met with a representative of OCC. PC not prepared to have the area fenced off. Field not suitable to winter use & OCC were not prepared to pay for the provision for an all weather pitch.

During the meeting EH advised WHPC that S106 money had been negotiated for the addition of 2 extra tennis courts without any consultation with WHPC.

### 90/15 CHAIRMAN'S ANNOUNCEMENTS

GG has been contacted by M Allen re safety fencing around the Church Farm development. This has been blown down several times in the recent high winds. Sweetcroft has been contacted & have tied it down. This is a matter for health & safety & not a PC matter. Residents have complained about the road closures next to the development, proper access roads have now been constructed so this should no longer be necessary.

There have been problems with water pressure in the village. Thames Water have been contacted & are monitoring.

## 91/15 CLERK'S REPORT

Received a letter from the Lord-Lieutenant of Oxfordshire reminding PC that in June 2016 there will be a national celebration of the Queen's 90<sup>th</sup> birthday. It wasn't thought that WHPC would be marking the occasion but would support any local initiative.
