Police would monitor situation & if necessary do their own checks & issue penalties. The speed guns would have to be purchased by PCs. It was suggested that several PCs could club together.

#### 83/14 THE PLOUGH

GG reported on recent developments. Initially £178,000 was pledged, this is not enough to buy the pub without a mortgage. If a private ltd company was formed more people were willing to invest. This has been done and a bank account has been set up. The Hanney Community Association has been formed to facilitate share issuing. This assoc. will also spearhead other projects.

It was thought that this association could be in conflict with the role of the PCs. It was suggested that a member of each PC be on the management committee to report back to their PC.
