#### 24/14 ELECTION OF CHAIRMAN

## 26/14 PARISH CLERK'S REPORT

Annual Accounts have been completed and internal audit carried out on 29/4/14. Vat Return submitted.

GG & CS booked on to Town & Country Forum on 17/6/14

Houses on Old Workshop land being sold. Letter from solicitors asking if PC was still willing to allow access to properties over Parish Land. Replied in the affirmative.

#### **27/14 CHAIRMAN'S ANNOUNCEMENTS**

**Chancel Liability.** Legal searches undertaken during the transfer of ownership of the Community Woodland discovered that the land may be liable for a chancel charge. P.Karney Treasurer of the PCC had informed the PC that when West Hanney House was sold to a Mr. Jackson in 1887 the Church Commissioners agreed to take on the liability of the repair of the Chancel of St James the Great, West Hanney. This was confirmed by the Church Commissioners in Feb. 2013. Their letter stated that 'The Commissioners have sole chancel repair liability and stand ready to fund all eligible repairs'. It was decided that it was not necessary to take out insurance.

The final bill for the costs of transferring the Woodland has been received from our Solicitors. The amount is £817.40 less £300 paid on account.

An official handing over ceremony is to be arranged. CS has approached Mrs Snewin (head mistress of St James Primary School) so that children can be involved.

After the ceremony a meeting is to be arranged for all interested people to form a management committee.

GG reported that he had looked into grants and all Government based ones have been closed. Forestry Commission offers a Woodland Planning Grant. The Vale may be able to help (Community Grants). There is also the possibility of pairing up with a timber company who will fell the timber.

It was decided that no donation would be given to it.

#### 33/14 NORTH GREEN

Following the query from solicitors re right of access over Parish Land a general discussion revealed that there was a need for a detailed map of the land owned by WHPC to be drawn up.

#### AP CS to contact Roy Williams to seek help.

Residents of N. Green have complained about the state of the land owned by Treble-Parker in the centre of the Green. Cllr. Matthew Barber to be contacted about compulsory purchase by The Vale.

This posed the question who would maintain the green in the proposed Rectory Farm Close development. This to be pursued after development started.
