# 24/22 - Public Participation

A resident of Church Street asked the council if they could look into who owned the steps leading from the layby in Church Street up to No's 5-8 as they were in need of repair. The Chairman stated that the council would look into this and that a councillor would go and look at the steps to make sure they were not a hazard. It was also suggested that the minutes of meetings for the period Aug – Dec 2013 be consulted to see who had been responsible to the last time the steps were repaired.

J Stagg stated that there would be a piece in the next Hanney News about the residents of St James Way making some repairs to the road to the south of the West Hanney Green.

#### 26/22 – Matters Arising from Minutes of Last Meeting

#### 27/22 — Chairman's Announcements

The Chairman attended the Nature Recovery and Biodiversity Webinar run by VWHDC on 10/5/22 Reviewed the surface water drains and levels in Church Street and Main Street with Gordon Kelman and Leigh Travers on 19/5/22

Attended the surveying of the ditch levels by Leigh Travers at 14 Church Street on 23/5/22 Reported on the successful Queen's Platinum Jubilee weekend celebrations held across the Hanneys between 3-5/6/22

Attended a meeting of EHPC, GARD and Thames Water on 21/6/22

#### 28/22 – Financial Report

The clerk presented the Income and Expenditure account for the period 3rd May 2022 to 4<sup>th</sup> July 2022. This was approved by the Councillors present.

#### 29/22 – Planning and Planning Enforcement

### P21/1095/FUL - Land off School Road - Erection of 15 dwellings and associated works

Cllr Peter Packham stated that the developers were going to check to see if the bank was in an acceptable condition to place the new footpath toward the School, but he was asked to remind the developers that this path was to be placed in the field behind the bank. The developers have also stated that the show home should be open by the end of the month. Cllr Peter Packham is to carry

on liaising with the developers and to make sure the bio-diversity elements of the planning conditions are carried out.

# P21/V1620/FUL – Deans Farm – Refurbish farmhouse, convert and extend existing barn as a single dwelling, and erect 7 new dwellings – Bat protection order on bats roosting in the loft of the farmhouse and barn

Cllrs Wilkinson and Packham met with Stuart White from the developers, who stated that at present they were only working on subsoil. The developers are not changing the house but were going to do some work on the old barn. The developers have replaced the surface drain and agreed to dig out the ditch at No14 Church Street.

Cllrs Wilkinson and Packham to carry on liaising with developers.

# P22/0397/FUL – Denchworth Manor – Demolition of existing ancillary building and proposed new dwelling

Application under consideration - No change

#### P21/V3205/FUL - Wicks House -

Application approved

# P22/V1054/SCR – Screening option for Environmental Impact Assessment (EIA) for an Anaerobic Digestion Facility on land at Bradfield Grove and a Digestate Lagoon in the Parish of West Hanney

EIA completed by Adrian Butler on behalf of VWHDC but if considered a waste disposal facility this EIA will need to be completed by OCC. Cllr Corps had circulated an email detailing some concerns about the size and location of this facility, the impact of significant lorry movements and the environmental risks posed by the digestate lagoon. These could have an adverse environmental impact on West Hanney. District Councillor S Povolotsky advised the Chairman to contact our County Councillor with our concerns.

#### 30/22 - East Hanney Public Facilities Proposal

No Change

#### 31/22 - Section 106 & CIL Payments -

It was pointed out that the council has up to 5yrs to use this money, so was decided to defer until later in the year to discuss.

#### 32/22 – Hanney Queen's Platinum Jubilee Weekend

A very successful weekend of celebrations. Costs of organising the event to be shared with EHPC as previously agreed. Councillors resolved to increase WHPC share of the costs from £250 to £300. £700 was raised by events at the Jubilee Fayre. The proposal by the Hanney Queen's Platinum Jubilee Working Party to spend this money on playground equipment was supported.

# 33/22 - Nigel Eady Community Woodland, Church Farm Meadow and the New Orchard

The apple trees are all looking ok. A new bench has been placed at the south end of the walnut avenue in the community woodland and a bench is due to be installed in the New Orchard with a view over Church Farm Meadow. A further 12 fruit trees and tree protection have been gifted to the Council for planting this winter in the New Orchard.

#### 34/22 – Roads Crossing West Hanney Green

The deteriorating condition of these roads not listed on the Highway Record Map was discussed. The Council accepted the offer by District Councillor Sally Povolotsky to make enquiries with Officers at OCC to see whether these roads could simply be added to the Highway Record Map.
